Time remaining for product certification

With 9 months left to obtain certification, we're concerned some of you won't be ready prior to 13 March 2022.

Technical documentation and APIs have been available in the Health Systems Developer Portal for Medicare Online for over 12 months.

If your software isn't updated, your customers may need to revert to HPOS, and this may create additional administrative pressure and costs for their business.

If you don't have certification

Book in for product certification now.

Product certification should be completed by **30 November 2021.**

This will allow enough time to roll out your product to your customers prior to 13 March 2022.

- No further bookings for product certification after 30 November 2021.
- You should finalise the transitioning of your customers.
