Notice of 2022 Annual General Meetings

The 75th Annual General Meeting of the Urological Society of Australia and New Zealand (USANZ) will be held at 3.00 pm (AEST), Saturday 30 April 2022 as a Virtual Meeting.

The Annual General Meeting of the Australian and New Zealand Association of Urological Surgeons (ANZAUS) will be held at 3.45 pm, immediately following the USANZ AGM, on Saturday 30 April 2022.

Participating in the virtual meetings

Following on from the recent changes to the Corporations Act 2001 to enable companies and boards to meet their legal obligations and convene annual general meetings entirely online, the USANZ and ANZAUS AGMs will be **virtual AGMs**.

When participating online, you will be able to view the meeting proceedings, ask questions of the presenters and vote. Only eligible voting members as set out below will be able to vote.

Eligibility to Vote

- All Full Members and Fellows of the USANZ are eligible to vote at the USANZ's Annual General Meeting.
- All ANZAUS members who reside permanently in Australia are eligible to vote at the ANZAUS Annual General Meeting.

Steps for participation in virtual AGM - changes to allow for questions from floor

USANZ has defined some basic steps for participating in the AGMs below. A detailed Instruction Sheet will be provided to members closer to the meeting date.

- To participate in the meeting on-line, members will need to have a smart-phone or tablet or computer that is sound enabled, has built in speakers or connected to speakers or headphones. You will need the latest version of Chrome, Safari, Edge or Firefox. Please ensure your browser is compatible.
 - On this device, participants will access Lumi AGM by going to https://web.lumiagm.com/396488046 or by typing this address in your browser.
- 2. Registration of members will commence from 2:30pm AEST. You may be asked to enter a Meeting ID to register. If so, **the Meeting ID is 396-488-046**.
- 3. You will then be prompted to enter a user-name and password.
 - a. **Your user-name** is the email address you have registered with USANZ in our membership register.
 - b. **Your password**: is your unique Member ID which has been included in the email from the USANZ Secretary which accompanied this notice of meeting. Your Member ID is also available in your Member Dashboard on the USANZ website. Please email secretary@usanz.org.au if you have difficulty in locating your Member ID.
