# PBS Authorities – Digital access to Alzheimer's disease

# May 2023

We understand having access to PBS-subsidised medicines can be critical to patient care. That's why Services Australia and the Department of Health and Aged Care are continuing to work together to increase the number of PBS medicines that can be requested and approved in 'real-time' using the Online PBS Authorities system (the system). This includes the recent changes made to the Alzheimer's disease medicines from 1 May 2023.

These changes will make it easier for you to request authority approval for these medicines from Services Australia. You will no longer need to submit hard copy authority applications, prescriptions and test results. Instead, you will be able to use the system to apply for authority approval and provide evidence digitally. Although changes have been made to the wording of certain prescribing instructions and administrative notes, the PBS patient eligibility criteria for these medicines won't change.
