**Overview:** This is an update from A/Prof Ken Sikaris and Prof Mark Frydenberg AM on the RCPA position statement on PSA Test Reporting chaired by RCPA CEO Dr Debra Graves OAM. The purpose of this updated position statement is to outline the optimal use of serum prostate specific antigen (PSA) in testing for the likely presence of prostate cancer. Blood levels of PSA are currently the best readily available biomarker for detecting prostate cancer. This position is aligned with the NHMRC endorsed PSA Testing Guideline Prostate Cancer Guideline produced by the Prostate Cancer Foundation of Australia and Cancer Council Australia<sup>2</sup>. The presentations will also review the alignment of the position statement with the Medicare Schedule for reimbursement in Australia.

**Speakers:**

**Prof Mark Frydenberg** specialises in urological cancer management, assessment of haematuria and raised PSA, management of benign prostate disease. Urologic Oncology Fellow Mayo Clinic 1991/2, Chairman, Department of Urology Monash Health 1997-2017, President Urological Society of Australia and New Zealand 2015-2017, Urology Council member, Royal Australasian College of Surgeons 2017 to present, Academic Director of Urology, Cabrini Health 2019 to present, Board member Peninsula Health.

**A/Prof Ken Sikaris** is a Chemical Pathologist at Melbourne Pathology and is also Director of Clinical Support Systems for Sonic Healthcare. A/Prof Sikaris held numerous national and international committee positions including Chair of the Australasian RCPAQAP external quality assurance program and the Chair of the IFCC Committee on Analytical Quality. He is currently on the IFCC Committee on Reference Intervals and Decision Limits as well as the Taskforce on Global Reference Interval Database. Dr Sikaris is a laboratory assessor (ISO15189) and an examiner for the RCPA and AACB in Australia. Dr Sikaris is also a member of the current Medicare Review Advisory Committee.
